- Length of Season: 32 Weeks: Monday, September 30th, 2024 to Sunday, May 11th, 2025. 1. The club is not responsible for acts of God, acts of nature or inclement weather. There are no refunds or court exchanges.
- 2. The Group Captain is responsible for the full collection of payments, the supplying of a complete list of players, contact information, and a schedule of play to EHIT.
- Group Court Placement at the Discretion of Management and may change week to week. **3.** We will make every effort to keep you on the same weekly court.
- Full court fee must be paid prior to August 1st, 2024. If not paid at this point, court may be 4. reassigned to next applicant on waiting list. NO REFUND UNLESS COURT IS SOLD.
- 5. All courts are subject to tax as may become applicable.
- With 48 HOURS notice of a session's cancellation, the club will attempt to sell your 6. court and either "bank" or credit a percentage of the court time if successful. Group captain may elect to make up the time subject to availability through June 30th, 2025.
- 7. All members (Indoor/Outdoor) may purchase additional hours at the Member Open Time Rate during the winter and summer seasons.
- 8. Seasonal court owners still have use of their time during all holidays.
- All charge accounts must be accompanied with member's or non-member's credit card and 9. e-mail address on file.
- 10. Proper tennis attire must be worn at all times, especially tennis sneakers due to the clay surface.
- 11. EHIT will take 30% for any and all transactions that we run through our system, even if the players get their own sub.
